Risk Assessment

Staticus opposes slavery in all its forms and has zero tolerance for slavery and human trafficking. Staticus is committed to ensuring human rights are respected and slavery is not taking place within our operations and supply chains. Considering where we do business, our sector, and our supply chains, we believe the risk of modern slavery or forced labour within our business or supply chains is very low.

However, should we identify any potential modern slavery or forced labour issues in our business or

supply chain, we will investigate them and take appropriate action to address any identified concerns. Policy on Modern Slavery and Human Trafficking

As a company we are aware that slavery and human trafficking, including servitude and forced labour, exists in every region of the world and in all types of economy and industry and is a growing issue; however, we are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. Both: This Statement and Modern Slavery and Human Trafficking Policy reflect our commitment to use only legal and ethical business practices and to implement and enforce effective systems and controls to ensure slavery and human trafficking are not taking place anywhere in our supply chains.

Employee Awareness and Annual Review

To ensure an understanding of the risks of modern slavery and human trafficking in our supply chain and our business, our employees are familiar with the content of the policy and the statement. Staticus Modern Slavery and Human Trafficking Statement is to be reviewed on an annual basis.

As with all alleged policy violations, we investigate issues and take appropriate action, up to and including termination of employment and/or termination of agreements with suppliers and contractors.

Progress

We are proud of the steps we have taken in FY25 to combat slavery and human trafficking; this includes the following:

- ▶ The introduction of a published Modern Slavery and Human Trafficking Policy available at our internal Corporate Policies site,
- ▶ A continued application of Business Conduct.

- ▶ Modern slavery and Human Trafficking risk assessment is an integral part of the supplier's evaluation process.

Further Steps

We intend to take the following further steps to combat slavery and human trafficking:

- ▶ Continue to review our approach to Modern Slavery to evaluate the effectiveness of the approach and identify gaps if any.
- ▶ Where necessary, make further improvements to our supplier screening process and risk-based assessment of vendors and suppliers; and
- ▶ Through targeted communication, embed knowledge of the issues and risks around modern slavery and human trafficking to appropriate staff globally.
